The "Cops" Cop



On June 28, 1992, Chief Daryl F. Gates retired after forty-three years of police service. He served in every rank and in a wide variety of specialist assignments. As the Los Angeles Police Department's forty-ninth Chief of Police, his almost fifteen years in that office was exceeded only by the legendary Chief William H. Parker who served almost sixteen years at LAPD's helm.

Chief Gates is a graduate of the University of Southern California where he did undergraduate and graduate work.

As a police executive, Chief Gates was chairman of the major cities chiefs association for four years (1988-1992). The association is a consortium of fifty police chiefs from this nation's and Canada's largest municipal and county law enforcement agencies. Chief Gates' counsel has been sought frequently by the nation's top officials - Governors, Attorneys General, Senators, Congressional Committees and including Presidents Of The United States - on matters of public safety.

Chief Gates developed the master plan for policing the 1984 Summer Olympiad in Los Angeles. The games were a spectacular success. His command of the law enforcement operations brought the chief and department high commendations from around the world. Chief Gates is widely recognized as the father of "DARE" (Drug Abuse Resistance Education). The program began in 1983 with the cooperation of the Los Angeles Unified School District.

It was the first program of its kind to be introduced in the Fifty States, New Zealand, Australia, America Samoa, Canada, Puerto Rico and Department of Defense Schools worldwide. Each year, 9,000 police officers teach over nine million youngsters how, with confidence and pride, to avoid using drugs.

Chief Gates pioneered the concept and implementation of law enforcement's first SWAT operation, which has become an

international model. He is recognized as an authority on terrorism, civil disorders and the applications of air support.

Chief Gates has written numerous articles on law enforcement and authored the "Number One" best-selling autobiography, "Chief, My Life In The LAPD", published by Bantam Books in 1992, and in paperback in 1993.

For fifteen months, he had his own radio talk show each day on powerful KFI 640 AM and has been credited by KFI management as raising KFI's ratings to the number one AM Talk Radio Station in Southern California.. In addition he hosted a half hour television reality show entitled "Behind Bars" every night for fifteen weeks.

He is a consultant to Sierra On-Line Inc. which develops sophisticated interactive computer games. His first game "Open Season" in the Police Quest series went on the market late in 1995.

He is sought after nationally as a public speaker and has toured the nation's Universities speaking on and debating the issue of crime and violence and drug abuse in America. He appears frequently on network and local television and radio shows discussing law enforcement related issues.

Chief Gates has his own company, "Chief", which provides domestic and international corporate security, including executive protective services, antiterrorism, legal gambling and community-oriented policing, and a wide variety of other subjects including swat tactics.

Chief Gates will be speaking on law enforcement in the 90's and will be present during the awards ceremony honoring citizens who have contributed to our community. 

This year the Kern County Sheriff's Foundation is proud to recognize two citizens in our community that have generously given of their time, effort and talent to organize and promote youth sports activities. "CITIZEN OF THE YEAR" honors will be presented to Gary Chapman and Tom Valos at the Foundation Citizen Awards Luncheon. The luncheon will be held on Thursday November 21, 1996 at 12 noon at the Red Lion Inn in Bakersfield, CA. In 1988, Tom Valos and Gary Chapman formed the TEXACO KIDS Youth Wresting Program to provide an arena of learning and competition for young, highly skilled and motivated wrestlers. All of the wrestlers are from the Kern County area and ranging in age from 5-14 years old. The positive results of this program speak for themselves as over the past 8 years the TEXACO KIDS have turned out 13 State Team Championships, 30 Individual State Champions, 23 Individual Regional (National) Champions, over 100 California National Team Members and multiple state placers. In 1995 the TEXACO KIDS made California youth wrestling history by becoming the first team to sweep all three Greco Roman wresting age groups. The goal of the program is not only involve young athletes in the competitive sport of wrestling, but also to further promote and enhance a spirit of awareness, dedication, team spirit and achievement that will form a positive platform of excellence to serve these individuals in their latter lives.

Gary Chapman, a native of Bakersfield, is the CEO of Sun Valley Oil Co., the independent Texaco distributor for Kern County. Through his association with Texaco, he has been instrumental in offering sponsorship to such community projects as: The Bakersfield college Athletic Field Scoreboard, the CSUB Gymnasium Scoreboard, the Centennial High School Athletic Field and the sponsorship of the TEXACO KIDS Youth Wrestling Program in addition to numerous youth athletic teams. On April 27th of this year, Gary was chosen to represent Texaco and our entire community as one of the Olympic Torch bearers on the first day of the 1996 Atlanta Games Olympic Torch Relay.




them and refining the difficult techniques of the sport, while instilling purposeful motivation and positive attitudes of achievement to these young athletes as they participate in wrestling competitions.

Both Gary Chapman and Tom Valos come from an ex-




1996 CSUB WRESTLING TEAM WINS THIRD IN THE DIVISION I NCAA FINALS COACH T.J. KERR TO BE HONORED AS CITIZEN OF THE YEAR.

Unbelievable! Unbelievable! said Coach T.J. Kerr this past March as he watched his small town college finish third at the Division I, NCAA finals. CSUB did it on a Saturday night at the division championships two thousand miles away from Bakersfield. This entire team should be commended and T.J. was named coach of the Year.

T.J. Kerr has emerged as a leader in the sport of wrestling. Not only does Kerr coach one of the most consistent top-25 programs in the nation, he is also the president of the National Wrestling Coaches Association, a leader in the women's wrestling movement and a major proponent in he battle for fair gender equality in college athletics.

Now in his 13th year with the Roadrunner wrestling program, Kerr can count among his credentials a career dual-meet record of 299-133-6 with ten finishes in the top 25 at the NCAA Division I Championships. In 1987, Kerr was named NCAA Division II Championships and current assistant coach, Darryl Pope, was named Outstanding Wrestler. Also, in 1987, Kerr was selected as West's co-coach in the NWCA's All-Star Classic where both Pope and Eric Mittlestead won individually. Kerr's success at CSUB stems from an illustrious 12 year career at San Jose State during which the Spartans earned 10 PCAA titles and two second-place finishes. He was named PCAA Coach of the Year seven times. Kerr, the current president of the National Wrestling Coaches Association, has contributed 15 years of service to mankind's oldest sport. With the elimination of many NCAA wrestling programs across the nation, he leads the NWCA in a critical time for survival of the sport. His term in office ended in September, 1996.

Kerr led the charge in bringing women's wrestling to CSUB becoming one of the first colleges in the nation to allow women to wrestle on their varsity wrestling team. His recruiting is two-fold, trying to reach experienced wrestlers as well as newcomers to the sport.

In addition to women's wrestling, Kerr has been at the forefront of athletic equality at the college ranks. Kerr has spoken at a U.S. House of Representatives Sub-Committee on Post-Secondary Education and Lifelong Learning Meeting on May 9, 1995.

Coach Kerr has been under tremendous pressure recently due to the demands made put on dwindling finances at the Cal State Athletic Program and must raise \$50,000.00 this year to continue the program. The Kern County Sheriff's Foundation recognizes Coach Kerr for his tremendous effort and his teams performance. Coach Kerr's 1996 season was amazing as they picked up the Pac-10 Wrestling title. If you consider the number of wealthy, high-populated schools that are involved in the national championships, CSUB's feat is unparalleled.

For these reasons the Kern County Sheriff's Foundation recognizes Coach T.J. Kerr as the Citizen Coach of the Year. Along with our other award winners, Gary Chapman and Tom Valos, these men have given hours and hours of their lives to positive youth and adult activities that make Bakersfield stand out in the state and in the nation. Well done CSUB!

CANINE TRAINING FACILITY PLANNED

The first major contribution by the Foundation to the Sheriff's Department was the gift of Murphy, a narcotics sniffing canine. Sadly, Murphy died very soon after the Foundation's spring luncheon at which he was present with his handler. He was so successful in his narcotics enforcement role that your board of directors developed a strong feeling of support for the sheriff's canine program.

It developed, however, that Murphy was the last of the specialized narcotics sniffers. Now there are four canine teams, consisting of handler and dog, in the sheriff's department. The teams are cross trained in both patrol and narcotics detection which allows a broader and more efficient use of them.

According to Deputy Mike Whiting, a canine team member, the dogs are a very effective law enforcement tool in many ways. They cut down on assaults on the deputies whom they accompany, because few criminals are fool-hardy enough to tangle with a fearsome looking dog. They can be useful in pursuit of criminals and in the search for them in buildings and dark outside areas where an officer might be subject to ambush. Thus they also increase the apprehension of criminal suspects.

As Murphy proved, they are a very superior means of detecting narcotics, which, of course, results in more seizures.

Whiting also said that the dogs reduce the number of man hours necessary for searches, and they provide better officer safety during searches. The dogs are very useful in crowd control and are a good public relations tool.

In 1994, the last year for which the statistics have been compiled, the canine teams had 3707 canine deployments resulting in 1026 arrests. Constant training is necessary to maintain and improve the dogs' proficiency, according to Whiting. For this reason the sheriff's canines are frequently entered into competitions in order to improve their ability to perform their assigned tasks.

The Sheriff's Department has asked that the Foundation take a leadership role in the development of a professional canine training facility that is specifically designed to meet canine training needs. The plan is to use county land next to the Lerdo Pre-trial Jail Facility on Lerdo Highway. At present, according to Commander Paul Montgomery, the teams are using "borrowed" or public areas such as parks, business parking lots and other such areas when available. This system frequently presents problems of availability as well as other inconveniences.

The plan for the facility calls for a grass field with lighting and an obstacle course, areas for narcotics and vehicle searches, a classroom and a few kennels.

According to Montgomery, "We are looking to design and build a facility that will serve as a "First Class" regional Training site for years to come."
