






President's Message

Another special "thank you" goes to board member



KERN COUNTY SHERIFF-CORONER RETIRES

Well folks, the Sheriff says it's time to hang up the guns and call it a career. After an illustrious 37 years with the Kern County Sheriff's Department, Sheriff Sparks decided to dedicate more time to his wife, Linda, and the rest of his family. That family includes a 35-year union with Linda, 3 children and 2 grandchildren.

Carl was born and raised in Kern County. He attended local schools and graduated from Bakersfield High School in 1958. After graduation, Carl attended both Bakersfield Junior College (That's what it was called in those days) and Lancaster Junior College. Throughout his career he also attended California State University Bakersfield. Sheriff Sparks proudly served his country for three and a half years in the United States Marine Corps with tours in Cuba, Japan and Viet Nam. Upon his release from the Military, Carl decided what his goal in life was: to be a Kern County Deputy Sheriff.

Carl Sparks was commissioned as a Deputy Sheriff in 1965. He spent the next 37 years rising in rank from Deputy to Sheriff of Kern County. Carl spent the majority of his career wearing the "Uniform". He liked the "Streets" and spent as much time as possible on them. He especially liked working late at night. "That's where the action is" he was often heard to say. Carl was a strong advocate of Law and Order and often went above and beyond to secure the perpetrator of a crime or to see to it that a victim of a crime was taken care of.

When Carl was reassigned to Search and Rescue, he found his forte and Kern County began to hear from him. He was responsible for educating people about the dangers of the Kern River and what the tasks of Search and Rescue were. He brought Search and Rescue to the forefront of the public eye and kept it there.

Carl Sparks was inaugurated as Sheriff of Kern County on January 7, 1991. He was reelected as Sheriff -Coroner on January 3, 1995 and again on January 5, 1999. During his 12 years as Sheriff, Carl was active in many local, state and federal associations and organizations. He has been an active member of the California State Sheriff's Association since becoming Sheriff and a board member since 1997. He is active in the National Sheriff's Association and has been a board member since 2000. There are many other organizations, which are too numerous to list, that Sheriff Sparks has involved himself in.

During his career, he was a presenter at the 1996 National Sheriffs' Association. He was an invited speaker for The Drug Court Program in 1994. Carl was a member of the Legislative Committee for Proposition 172 (1/2 cent sales tax for Public Safety). Was a member of the Legislative Committee for Three Strikes and you're out. He was the 1984 Kern County Law Enforcement Officer of the Year. In 2000, he was the recipient of the Lifetime Achievement Award for an Elected Official by the Public Employees Roundtable of Kern. Sheriff Sparks is a graduate of the F.B.I. Academy in Quantico, Virginia.

Sheriff Carl Sparks was a Sheriff of and for the common man. It made no difference if you were Governor of the State or a homeless person; you were treated with respect and professionalism. Carl is and has always been plain spoken and to the point. You always know where you stand with him. In fact, it has been said that Carl is the ultimate politician; once you engage him in conversation, it's hard to get him to stop talking.

Sheriff Sparks, enjoy your retirement!

A Law Enforcement Legend In His Own Time?

Many things will be said and written about Carl Sparks over the next several months, but those of us who worked side by side with him over the years have many stories to tell.

First of all, Carl has always been known for his extraordinary high speed driving, short response times and a string of Sheriff vehicles in the County wrecking yard.

As an example, one night Carl was enroute to home for dinner in the southwest when a "shots fired" assault with a deadly weapon call, the call was in east Bakersfield. The closest car responded from Union Avenue driving as quickly as they could. Carl called in on the radio enroute, and imagine the deputies' surprise when Carl not only beat him to the call probably 10 to 15 miles further away, but had already gotten the drop on the bad guys and yet left him to do the paperwork. We can only imagine it remained the same as Sheriff.

Retired Commander Frank Williams who went through the sheriff's academy with Carl recalls everyone wore suites and ties and Carl, being a former Marine, tried his best to be "spit and polish" officer and was the first to try anything. Frank still to this day is happy Carl got the ultimate job of Sheriff.

Several deputies commented about Carl's unquestionable dedication and devotion to the Sheriff's Department. Carl's pride in the department is obvious.

Finally, on Carl's position in the media, some say he is too strong or too tough, but Larry King said to Attorney General Bill Lockyear, "I like your Sheriff and his ideas." Carl had just arrived on the show after his deputies had rescued two young females from certain death. He spoke from the heart, not as a politician, but someone who has seen it all and knew what could have happened. It seemed that a simple statement confirmed that for once and for all, good had won out over evil. That certainly is the goal of the Sheriff who worked up through the ranks, learning as he went sometimes dealing with controversy, but always with conviction and commitment to the safety of Kern County.

An era has passed, and we all wish Carl and Linda a long and healthy retirement.





The seven-foot plus tall center monolith had the prayer called "The Monument" engraved into it under the Sheriff's Star. It reads:

"The Monument"

I never dreamed it would be me, My name for all eternity, Recorded here at this hallowed place, Alas, my name, no more my face.

"In the line of duty" I hear them say, My family now the price will pay. My folded flag stained with their tears; We only had those few short years.

The badge no longer on my chest,

There are two six foot plus monoliths that flank the center monolith. On the left are the eighteen names of the sworn deputies sheriff killed in the line of duty. On the right stands the monolith with the ten names of the volunteers who gave their life serving us. The plaza itself is made up of 124 granite pavers that individuals and businesses in the community bought and had their personal message engraved into it. Some are very poignant and some very thought provoking. You will have to see the monument to appreciate the grandeur and yet simplicity.

The Honor Guard, in all their regalia posted the flag of our nation. A bugler wailed the ever somber "Taps" from the distance. The bagpiper, complete with kilt and full military uniform blew the tear jerking "Amazing Grace" on his crying pipes. A helicopter flyover paid their respects. A twenty one-gun salute broke the silence with a resounding boom. A lone, unknown deputy stood by an empty patrol car at attention. Each man's name was read aloud. The prayer was read to the crowd. All the top brass was there in their Class "A" uniforms—the sun glinting from all the gold.

Twenty-eight white doves—one for every man on the monument— were released in their honor. There wasn't a dry eye to be seen.

I hope and pray that the mournful slain deputy who spoke the spiritual words in the prayer would be granted his wish by God—— "......let my name be the last".

SCHOLARSHIP UPDATE

For the last several years, the Kern County Law Enforcement Foundation has awarded an Annual scholarship to a Kern County high school senior entering college who is pursuing a career in the field of law enforcement or criminology. The scholarship totaled \$4,000 and was made in biannual payments over a four-year period.

We have two students currently active in our program. Justin Smith is attending Cal State University Bakersfield. He is a graduate of Stockdale High School and was our 2001 recipient. Curtis Rhoades is attending, Bakersfield College, he is a graduate of Centennial High School and was our 2002 recipient.

Additionally this year, Dr. Robert Fong, Administration of Justice Chair at CSUB, contacted us. He had an exceptional group of students enrolled in the Criminal Justice program that were in need of assistance. The Board of Directors voted unanimously to make a one-time award to two students in the amount of \$1,000 each. Recipients, Allison Rickels and Debbie Welty were very appreciative of the donation made by the Foundation.

The Board is currently reviewing our scholarship program to ensure that we are accomplishing our goal of assisting a college student in becoming a leader in law enforcement in Kern County. The new guidelines for scholarship recipients will be published in our next newsletter.
