Shafter City Manager John Guinn was awarded with the "Citizen of the Year Award" for his "over the top" leadership and support of quality law enforcement in the City of Shafter. All of us on the Board felt he is one of the most progressive and open minded City Managers in the valley.

"Exceptional Citizen of the Year Award" was given to Ricardo Cordova Nieves for his willingness to get involved and assist law enforcement in apprehension of criminals even with danger to himself. Drew Heredia was also awarded an "Exceptional Citizen of the Year Award" for his bravery in keeping a pit bull from injuring a girl. His karate training and moves paid off in the end.

"Public Service Awards" were presented to Kern County Pro-Correctional Officers Mark Lora, Bill Williams, Darrick Duran for exemplary performance and going the extra mile to make the Kern County Probation Department programs work.

Real everyday HEROS were presented with the" Exceptional Officer of the Year Award"; Master Sgt. Thomas Dina of Edwards Air Force Base, Officer Gabe Sanchez and Officer Mark McGary of the California Highway Patrol and Officer Brent Stratton of the Bakersfield Police Department. Officer Mark Mc Gary received recognition for achievement above and beyond the call of duty.

One of our top honors for bravery came next; our "MEDAL OF VÅLOR" for those public safety officers who put their lives at risk in an attempt to save others. CHP Captain Brian Smith presented Officer Joshua Hatfield the honor for heroism and his willingness to enter a burning vehicle and try to save accident victims in the vehicle. He was seriously burned and injured and the car blew up shortly after his last exit. He was very reserved, recognizing the emotional trauma he endured and the terrible tragedy he went though. After listening to Captain Smith's description of an unselfish attempt of Officer Hatfield to save these people; you just don't think of what our officers are exposed to daily until you have walked in their shoes.

The "Officer of the Year" award was presented to two deputies with the Kern County Sheriff's Department. Deputy Thomas John Moore was presented our highest award for his exceptional service with the KC Sheriff's Department. Sheriff Donny Youngblood stated that Deputy Moore responded to a residence in McFarland, on a report of a male suspect who had possi-bly shot his wife, and was still armed at the family residence with children inside. The sus-pect, who was in the front year immediately confronted Deputy Moore and fired at Deputy Deputy Moore was shot in the face by the suspect, causing a rupturing of his left Deputy Moore put his life on the line to protect the citizens of McFarland, and the suspect's own family members. For his outstanding bravery, he was recognized by the crowd with a standing ovation.

Sr. Deputy Sean Pratt was also awarded the "Officer of the Year" award for his outstanding service with the Kern County Sheriff's Department. Deputy Pratt was involved in several cases; McNew Triple Homicide; Golden West Casino Robbery; Grange Homicide; Brownbey Attempted Homicide; Niles Street Homicide and Delano Gang Investigation, just to name a few.

"Legends of Law Enforcement"

Chief CHARLIE FIVECOAT Shafter Police Department

Chief Charlie Fivecoat was raised in Kern County and is a veteran of the Vietnam War. He has a Masters Degree in Public Administration and is a graduate of the FBI National Academy.

Chief Fivecoat began his career in Public Safety in 1974, working for both the Taft Fire and Police Departments. He later became a Deputy Sheriff ultimately obtaining the rank of Division Commander. Chief Fivecoat retired from the Kern County Sheriff's Department in October of 2001 and spent the next five years as a full-time college professor at Bakersfield College. During his tenure at Bakersfield College, Chief Fivecoat taught International Relations, Comparative Politics, and American Government. He was also voted the Bakersfield College "Professor of the Year" for 2003.

In July of 2006 his passion for law enforcement was again rekindled when the City of Shafter asked him to become their Chief of Police. During the past three and one-half years Chief Fivecoat has been responsible for building a new police department, animal control facility, and remodeling the City's contract prison facility. He has also instituted several citizen and youth programs including a Police Activities League and is the countywide administrator of the Kern AVOID anti-drunk driving task force. His single greatest vision for the Shafter Police Department was to make the organization an integral part of Kern County Law Enforcement and he is currently completing a regional firearms facility which will be used by several agencies throughout the County.

During his career with the Kern County Sheriff's Department he worked all over the County at various substations and in metropolitan Bakersfield. Chief Fivecoat seems to work best at change. He relocated the Sheriff's Technical Investigations Unit to the Norris Road Facility and modernized its photographic and automated fingerprinting capabilities. He then took control of the Sheriff's fleet from the General Services Department and modernized it to meet the department's increasing needs. He later worked to help consolidate the Coroner's Office with the Sheriff's Department and then introduced and fought for legislation which funded the Sheriff's Rural Crimes Detail. He has worked many special assignments including undercover narcotics and was a member of the Sheriff's Special

Weapons and Tactics (SWAT) Team for fifteen years. During his tenure on the SWAT team he instituted the Scout Sniper Team and obtained F.B.I. Accreditation for the Bomb Squad. He ultimately served as the SWAT/ Bomb Squad Commander for the department prior to retiring in 2001.

He and his wife Dolores have been married for four years and

enjoy time with their \sin children and five grandchildren. Dolores and Charlie also enjoy running $\frac{1}{2}$ marathon and marathon distance events, sailing, and other outdoor activities.

Charlie plans on returning to Bakersfield College as an adjunct professor and has not ruled out other career opportunities in the future.



Chief WILLIAM RECTOR Bakersfield Police Department

Chief Rector was born and raised in Bakersfield. He attended local schools, graduating from Garces Memorial High School. His college education includes a Bachelor of Science Degree in Criminology from Fresno State University; Vocational Teaching Credential from UCLA; and a Master of Arts Degree in Counseling from Cal State University, Bakersfield. He is also a graduate of the Commission on Peace Officers Standards and Training, Command College.

Chief Rector has been with the Bakersfield Police Department for 27 years. He has worked in all divisions of the department during his career including Patrol, SWAT, Training, Sex Crimes, Narcotics, and in Headquarters as the Assistant Chief for five years, prior to being appointed as Police Chief in 2004.

Chief Rector focused the department on the following goals:

- 1. Reducing Part 1 Crime, gang crimes, and increasing traffic safety.
- Enhancing the department's transparency through accessibility to the community.
- 3. Increasing the use of technology for smarter policing

- through crime analysis and data sharing.
- 4. Enhancing the department's relations with the community and other law enforcement agencies.
- Ensuring a positive outcome from the Department of Justice Investigation
- 6. Preparing leaders for the future

Over the course of his tenure, staff at the department has completed many competitive grant applications and achieved these goals.

Over the past five years the department has been fortunate to receive approximately 10.6 million competitive/non-competitive grant dollars.

During Chief Rector's tenure, the department has also received three state awards for the following:

Chief Robert's thirty-two year career with the Kern County Probation Department includes service that spans the operational range of field, administrative, institutional, and management. After directing programs at juvenile hall and Kern Crossroads Facility, he was appointed Assistant Chief Probation Officer in 2001, overseeing both Adult and Juvenile Probation Field Service units. Appointed as Chief Probation Officer in 2004 by the Kern County Superior Court, Chief Roberts heads a department of 549 employees, three juvenile treatment facilities, and one detention facility. Chief Roberts, a graduate of Garces Memorial High School and California State University of Bakersfield, has been involved in numerous professional and volunteer activities, among which are:

Chief Larry Bentley began his Law Enforcement career with the Kern County Sheriff's Department on August 4, 1969 after a year as a Reserve Deputy Sheriff. During Larry's tenure with the Sheriff's Department, he served as a Deputy, Investigator and Sergeant

with assignments to Corrections, Patrol, Detectives, Vice/ Intelligence and the Narcotics Unit as well as being assigned to SWAT. During Larry's assignment to Vice/Intelligence, he developed his career long love for anything "gang related" and eventually became an expert on the subject. During this period and into his assignment as the Sergeant in the Narcotic's Unit, Larry served on California's Prison Gang Task Force Steering Committee and became a life member of the California Narcotic Officer's Association. Along the way, Larry earned a Lifetime Limited Teaching Credential (limited to Criminal Justice Subjects), and was given the opportunity to instruct Peace Officers in the areas of Narcotics, Vice and Gang related subjects. Larry also became involved with instructing the private sector in the areas of drug testing, identifying and supervising employees believed to be abusing alcohol and/or drugs in the workplace.

In December of 1987, after 18 years with the Sheriff's Department, Larry transferred to the Kern County District Attorney's Office as an Investigator until his promotion to

Lieutenant. In August of 2000, District Attorney Ed Jagels appointed Larry as Chief Investigator with oversight of the District Attorney's Bureau of Investigations.

Larry asserted that his proudest accomplishments stem from gang investigations. While working alongside State and Federal Agencies with the State Prison Gang, the Nuestra Familia (NF), Larry and others assisted with indicting and convicting the leadership of the organization under Federal R.I.C.O. statutes that had historically been used for organized crime offenders. Many of those indicted had ties to, or were residents of Kern County.

Larry said that his decision to transfer to the DA's Office was a difficult one because his career at the Sheriff's Department was rewarding. He said that he enjoyed working with his many friends and Command Staff, but at the same time he felt that his career with the Sheriff's Department had stagnated due to a slowdown with hiring and promotional opportunities. Larry said that the opportunity to work with District Attorney Ed Jagels, coupled with the opportunity to grow professionally were the deciding factors in his final decision to transfer. Larry's promotion to the position of Chief Investigator is proof that he made the correct decision.

Larry says his plans for retirement include volunteer work with the American Red Cross and doing some teaching in the Criminal Justice Field. With 41 years of experience in criminal investigations, Larry has a wealth of information to share. Larry and his wife Pat, a Marriage/Family Therapist, will also enjoy traveling as much as possible..

in South Lake Tahoe and after graduation from South Tahoe High School; she attended Southern Oregon College and the University of California Santa Barbara where she obtained a Bachelor of Arts Degree in Psychology.

From there Claudia continued on to Cal Poly San Luis Obispo for a fifth year where she earned her lifetime teaching credential. However, a series of unanticipated events led her down a different career path and Claudia started a career in law enforcement with the Kern County Sheriff's Department as a deputy sheriff on June 4, 1979.

Claudia attended the 26th Basic Peace Officer Academy which, with 52 cadets, was the largest class in the Academy's history; and, yes, Claudia found she was the only female. Claudia graduated 2nd in her class and worked a variety of assignments as a deputy and senior deputy, including corrections, metropolitan patrol, the Emergency Vehicle Operations course, Communications, undercover assignments in Vice, and as an acting sergeant in the Wasco Substation.

The year 1985 began a series of "firsts" for Claudia. In that year, she was the first woman in the history of the Sheriff's Department to reach the rank of sergeant. During the four years Claudia was a sergeant; she applied for and was accepted into the Master's program at Cal State Bakersfield, and in 1988 was awarded a Master's Degree in Public Ad-

In 1989, she became the first woman to reach the rank

of lieutenant, and in 1990 she became the Sheriff's Department's first female commander. Claudia remained the only female commander in the Sheriff's Department for the fol-

During her management years in the Sheriff's Department Claudia worked various positions, including watch commander in metropolitan patrol, Litigation Coordinator in Personnel, Area Commander for the East Kern Substations Divisions, Volunteer Services Commander, and the Training Division Commander. As a Commander, Claudia has left her footprint on the Sheriff's Department with projects like the remodeling of the Sheriff's Gym, refurbishing of Building F, Construction of the POST & STC training rooms, and the reconstruction of the firearms training facility including construction of the live fire house.

After completing 25 years of service with the Sheriff's Department, Claudia retired in March 2003, but her law enforcement career did not end there. After a brief 2 month retirement, Claudia again accomplished a "first" when she was selected as the first female police chief California State University, Bakersfield has had. After a very rewarding 7 years at CSUB, Claudia will be retiring May 1, 2010.

Claudia enjoys physical activities including running, reqular gym workouts, biking, tennis, and skiing; and she is looking forward to having more time to spend in pursuit of those interests; as well as being able to spend more time with her husband, Steve and daughter, Janelle. Claudia is looking forward to some relax time after retirement, occasionally helping Steve out in his fourth grade classroom, and seeing her daughter off to college; but she may consider other career opportunities should they present themselves.

District Attorney EDWARD JAGELS Kern County District Attorney's Office

The day Edward R. "Ed"
Jagels announced
his retirement was a sad day for
the multitude of supporters he's
accumulated in the span of a 35
year career (27 of those years at the
helm) with the Kern County District
Attorney's Office. His compassion
for crime victims will be missed
by all citizens who reside in Kern
County. His decision to retire was
undoubtedly a joyous event for a

undoubtedly a joyous event for a gaggle of Defense Attorneys and the criminals they defend, who no longer have to face the tenacious leader of one of the most successful District Attorneys Offices in the State of California.

Ed grew up in San Marino in the Southern California area. His father was an attorney and businessman so it was a natural progression for Ed to eventually become an attorney himself. Ed graduated from the prestigious Stanford University and UC Hastings College of Law

In early 1975, Ed joined the Kern County DA's Office as a Junior Prosecutor under the tutelage of then District Attorney, Al Leddy. A young Ed Jagels hit the ground running and it wasn't long until he had earned a reputation as a tough prosecutor who possessed excellent courtroom skills enabling him to garner the respect of his fellow Prosecutors, Judges, Law Enforcement Officers and the adversaries he faced in the courtroom.

I met Ed Jagels when he was a freshman with the DA's Office and had the boyish look of a 17 year old. At that time, I was a young Deputy Sheriff working at the Lamont Substation. Ed prosecuted a number of felony cases in which I was the arresting Officer or played a major role in the case. I too began to respect his ability as an attorney and his courtroom savvy.

In 1982, Ed announced that he was a candidate for the top job as the District Attorney. When I was asked to support Ed and join his campaign, there was no hesitation on my part. At one of the initial campaign meetings, we were brainstorming for a campaign slogan. I suggested "ask a cop" and it was embraced immediately because Ed overwhelmingly had the support of all the Kern Law Enforcement Communities. Ed was tough on crime as are Deputy

Sheriffs and Policeman so the slogan spoke volumes about the man and his intentions if elected. Obviously Ed won the election and has run unopposed in every election since his first.

During Ed's 27 years as the District Attorney there have been controversies along the way, but Ed always attempted to do the right thing, often from the heart, and never lost sight of the victims and the oath he took. He demanded that his prosecutors pursue the truth and aggressively try their cases in the interest of justice and represent the people to the best of their ability.

represent the people to the best of their ability.

During Ed's tenure as the District Attorney his office gained the reputation for putting a lot of people behind bars. In fact, there is only one county in the state that puts more criminals behind bars than Kern County. That statistic has its critics, but there is little doubt that many lives have been saved due to the efforts of Ed Jagels and his team of prosecutors. It should also be noted that the effort to place criminals behind bars is what is desired by the vast majority of people in Kern County and is what they expect from their DA's Office. The fact that Kern County once had the highest per-capita prison commitment rate of any California County, but recently dropped to

2nd place, is a source of pride for Jagels.
Ed's influence has reached far beyond Kern County. Former Assistant District Attorney, Dan Sparks, said "Jagels has been outstanding for the state of California. Prosecutors from around the state seek and respect his advice on almost every issue of public safety." In 1986, Ed Jagels led a statewide campaign to remove Rose Bird and two other justices from the California Supreme Court over their opposition to the death penalty. This was critically important for the safety of the people of California. The Bird court overturned virtually all the death penalty cases before it. Also during his tenure, Ed was appointed to the Governor's Law Enforcement Steering Committee and later was appointed as the Chairman of the Attorney General's Council on Violence Prevention.

Ed was later to spearhead reform under Proposition 115, which sped up the preliminary hearing process, allowing peace officers to testify about what witnesses told them. No longer could Defense Attorneys keep rape victims on the stand for days. Proposition 115 also refined the jury selection process, restored grand jury indictments, created the crime of torture and streamlined criminal procedures.

Ed Jagels is and always has been a strong supporter of the Three

Strikes Law in California, which allows a defendant with two prior serious felony convictions to be sentenced to 25 years to life in State Prison. Jagels said that the law goes after "those guys who are most likely to re-offend."

Given his background and history as a crime fighter, it should be no surprise that Ed is opposed to California's effort to release dangerous felons from prison early. During his last months in office, Jagels has been working tirelessly to minimize the effort State Officials are making to have inmates released back into the mainstream of society prior to serving the time adjudged.

At the local level, Ed says he is most proud of the good relationships his office enjoys with the Law Enforcement Agencies in the county, the strengthening of his office's investigation unit and transforming the crime lab into one of the premier labs in the state. Ed is always pleased when his office is able to obtain a conviction by using a broad array of innovative techniques available today. Ed gives his prosecutors a lot of praise for their hard work and credit for their extraordinary record of success, especially in light of the heavy case loads they routinely encounter.

Ed's latest year long endeavor has been the targeting of 115 "shot callers" in local gangs and attempting to place as many as possible behind bars or put them out of commission. By the end of summer about 90% were off the list by either being in custody, dead, moved out of state or subject to warrants and pending cases.

When you look back at the career of Ed Jagels and what he has accomplished just in the form of convictions, it is truly mindboggling. Then, consider the positive impact he has had with the implementation of various procedural changes that have streamlined the trial process, you are in awe. It is difficult to comprehend what Ed Jagels' contribution has meant to the people of Kern County and the State of California because he has done so much. Many of us have had the privilege of working alongside Ed Jagels' to make Kern County a safer place but every citizen has benefited from the passion he brought to his job.

Ed's plan for well deserved retirement is to do some hunting, fishing, snow skiing, reading history and spending time with his 10 year old son, Jeff. Ed has no plans to run for another elected office and intends to continue living in Bakersfield. Enjoy yourself Ed, you'll be sorely missed!

Our most recent recipient is Kelsey Taylor. Kelsey graduated from Ridgeview High School in 2009. Her GPA has ranged from 3.2 to 4.4 with an overall average of 3.5. She has been in the GATE/Honors program since her freshman year. She earned the honor of National Honors Society and was ranked 38 out of about 700 students in her

senior class. This ranking has given her an automatic acceptance into the Hawks Honor program at California State University and a guaranteed open at a university of the University of California system. She has been volunteering at the Bakersfield Police Department as a Law Enforcement Explorer since October 2006. She has been required to put in at least 15 hours a month of volunteer work through this program.

Kelsey's first choice of college is CSUB and her second choice is Bakersfield College.

This program is exceptionally rewarding to our Board of Directors, reinvesting in our future Law Enforcement leaders is a goal of our Foundation. We wish both recipients continued success.




Bill was born in 1912 and spent most of his youth in the Wasco area. He moved to Bakersfield in 1937 after earning a degree



In 1960 Bill earned his Teaching Credential and began his second career, teaching Spanish and Creative Writing at Arvin High School. While Bill was a teacher and mentor he touched the lives of many and was always there to help anyone in need. That trait would earn him the respect of his students and fellow teachers. Bill had a positive influence on many, especially his students, guiding and motivating them to become productive members of their communities.

Jon Busby and I both grew up in the Arvin area and attended Arvin High School. We recently shared information about Bill after his passing. Jon told me that "he noticed that during the funeral services everyone referred to Bill as Mr. Dolan. This was because of the respect they have for the man and the positive impact he had on their lives." Jon remembers when he was in Mr. Dolan's Spanish class; he insisted that the students get it right. Jon said that the love Mr. Dolan had for his students had been overwhelming.

When I was a senior at Arvin HS, Bill and I once spoke about my plans for the future. I told him that I planned to become a Deputy Sheriff. That's when I first learned

that he was a former Undersheriff. I remember how impressed I was. The first time I ran into Bill when I was in uniform was several vears later at an Arvin HS football game. We reminisced about our conversation when I was a senior in High School, about my career goals and his Law Enforcement background. I'll always remember how approachable Mr. Dolan was and that he always had time to listen to what you had on your mind. I'll miss that.

Law Enforcement was always part of Bill's life even after he switched careers to become a teacher at 48 years of age. In 1988 Bill joined forces with John Smith, then Sheriff of Kern County, and others to form the Kern County Sheriff's Advisory Council, currently known as the Kern County Law Enforcement Foundation. Bill proudly served two years as the organization's first President and remained an active member of the Board of Directors until his death on October 4, 2009. During Bill's tenure on the Board of the Kern L/E Foundation he played an active roll, often taking the lead with obtaining funds or vital equipment for Law Enforcement Agencies within Kern

Bill Dolan accumulated a long list of accomplishments during his 97 years of life. His shining example as a human being touched the lives of so many and positively influenced all who knew him. Bill will surely be missed by all of us at the Kern County Law Enforcement Foundation and we will do our best to continue the good work that he started when he co-founded the organization 21 years ago. The Kern County Law Enforcement Foundation will always be part of the legacy he leaves behind and there is no doubt that Bill is looking down on us. We will carry

on with the good work he started and try to make him very proud.
